<u>Did you know</u>: School zone or when children are around, the speed limit when driving within 500 to 1,000 feet of a school while children are present is 25 mph unless otherwise posted.

<u>Residential or Business Areas:</u> The speed limit in the residential or business areas is 25 mph unless otherwise posted.

Safety Zone: (Near Streetcars, Trolleys, or Buses) A safety

zone is an area of the road where street cars or trolleys are sharing the road with you. A safety zone is marked using raised buttons or markers.

Alleys: The speed limit for alleys are 15 mph.

**Blind Intersections:** The speed limit for a blind intersection is 15 mph. A blind intersection is an intersection without a stop sign and as you approach the intersection within 100 feet, you cannot see the cross the traffic from either direction from 100 feet.

**Brush Management and Fire abatement utilizing Goats:** The Brush Management utilizing Goats continues to progress a little slower than anticipated. This is due to a couple of setbacks experienced by the vendor.

The Goats will continue to work through the Artesian Ridge neighborhood, hopefully completing that area next week. They will then be turning their efforts and focus upon the canyons of Lower Scarborough Court, through to South Chevy Chase. This stretch will take some time to get through as the brush is thick in a few places.

The Fire Marshal has been on-site to confirm the location required for the Shepherd's quarters which comprises of two new caravans. The Fire Marshal requires the Shepherd's quarters to remain within a certain proximity of the working goats for safety and security purposes. The caravans will only be situated for period of time until the brush management is completed. Please stay clear of the caravans thank you.

Please keep well clear of the Goats and working area, to include the electric fencing and Goat protecting dogs. While observing the Goats working from a far is fine, getting close to the fenced off areas is not.

Thank you in advance for respecting this request and your understanding, as Del Sur works through its brush management requirements for 2020.
