Instructions on how to Report a Street Light out:

1. Go to www.sandiego.gov/street-div
2. Click on submit a service request
3. Scroll down and click on Streets, sidewalks & lights
4. Click on Street lights
5. Enter the address that is closest to the light needing service
6. Upload any pictures you might have of the problem area
7. Click Next
8. Enter your contact information
9. Click next
10. Verify information is correct
11. Click submit

FOCUS OF THE WEEK:

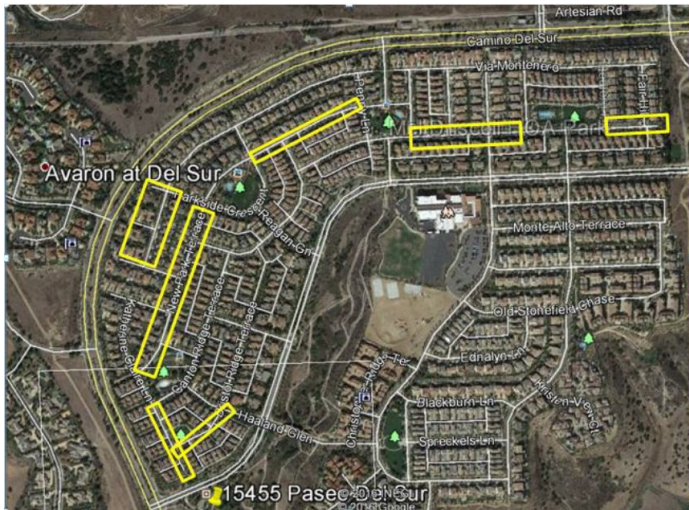
GENERAL MAINTENANCE: LEAF DEBRIS

With the excessive Santa Ana winds at the start of the week we are focusing on the leaf and debris clean-up throughout the property.

When we are in your area for our rotation expect that the crew will be working on minor pruning and any shrubs that need to be cut back for the fall/winter season. However their main focus will be on the leaf drop from the fall trees (Chinese Elms, Sycamores, Pistache).

Thank you for your cooperation in advance to allow the crew to work through this process.

RED FESCUE AREAS



FOCUS OF THE MONTH:

IN PROGRESS ACTIVITY: RED FESCUE PARKWAY PLANTERS

We will be focusing on the red fescue in the parkway planters in Increment 1 over the next month.

The process commenced on Nov 5th with:

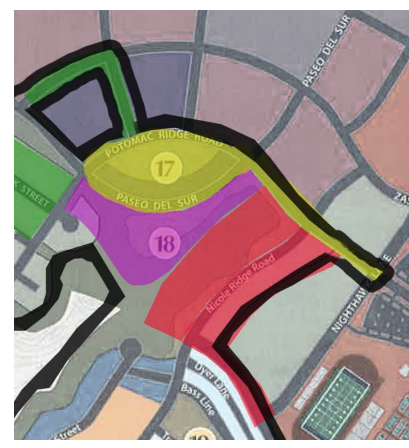
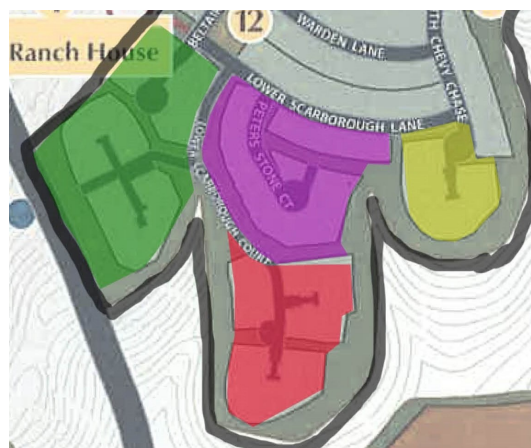
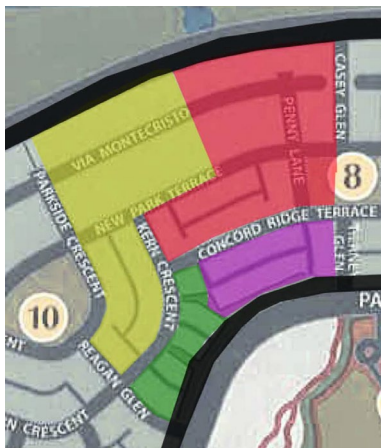
- Spraying the existing weeds and grass on Nov 6-7 to stop their growth (these locations are exempt from the pilot program)
- Renovating existing turf to remove thatch
- Mow/scalping the existing material
- Seeding over with a tall Fescue/Rye mix and applying topper.

We have roped it off and are asking the members of the community to please keep off the new grass for 30-45 days to allow it to germinate and fill in completely.

We will be watering 3x/day for the next 3 weeks minimum to get the seed to germinate. Please expect to see water running during the day in these areas.

Once complete and after the first mow we will remove the ropes and it will be safe to walk on the grass.

Rotation: We have completed Week 2 and are moving in to Week 3 in our standard rotation schedule.

Peppermint Hot Chocolate

Ingredients

- ❖ 1/3 cup unsweetened cocoa powder
- ❖ 1 quart milk
- ❖ 1/2 cup semisweet chocolate chips (3 ounces)
- ❖ 7 peppermint sticks; 3 crushed (1/4 cup), 4 left whole
- ❖ pinch of salt



Directions

- ❖ Place cocoa in a medium saucepan. Gradually whisk in milk until cocoa has dissolved. Add chocolate chips and crushed peppermint; simmer over medium heat, stirring occasionally, until chocolate and peppermint have melted, 8 to 10 minutes.
- ❖ Bring to a boil and immediately remove from heat. Add salt. Ladle into mugs; serve each with a peppermint stick.
