IMPORTANT: The instructors will need to submit this form, the signed waivers for each student & updated liability insurance *naming Del Sur Community Association, Black Mountain Ranch LLC, & FirstService Residential as additionally insured* to the HOA office *before* your reservation will be confirmed and swim lessons commence.

All swim instructors must come into the Ranch House *EACH SWIM SEASON* and obtain a new ID card.

SCHEDULING:

All swim instructors must call the HOA office at 858-759-1921 to schedule the time, date, and location they would like for their swim lessons. A calendar for each pool will be maintained by the HOA staff to avoid any conflicting lessons. Only ONE swim instructor will be permitted to reserve at one time. All reservations will be a first come, first serve basis and will have an allotted *maximum time of 4 hours* for instruction. The calendar will also be distributed to the pool monitors for them to inspect at random. Please see the next page for scheduling times.

The following are the pools and times that are the *only* pools available for swim lessons: *Beltaire, Jaqueline, Trent, Reagan Glen, & Old Stonefield*. Pool times: (Monday – Friday 6:00 am – 6:30 pm)(Saturday & Sunday 8:00 am – Noon)
Please ensure that you comply with all requirements.

I expressly acknowledge that the Association's swimming pool is for the non-exclusive use of all Del Sur residents and their guests, and that use of the swimming pool for Lessons does not entitle the Swim Instructor to prevent or hinder others from using the swimming pool at any time, including times when the Lessons are being performed. Further, I agree that the Swim Instructor will show consideration for other swimming pool users and will not engage in any activity that directly or indirectly prevents or significantly hinders others from using the swimming pool.

In the event of a maintenance or accidental issue causing a closure of any of the aforementioned pools, the instructor will need to contact the HOA office to find an available pool to perform their lesson. If all specified pools are occupied, the instructor will need to reschedule their lesson for a future date.

You will receive a certified letter notifying you 30 days in advance of your liability insurance expiration. You must submit a new certificate PRIOR to the expiration or you will not be permitted to conduct lessons.

Failure to comply with requirements will result in the *swim instructor & family* being banned from using any and all pools within the Del Sur Community.
